Any such policies and procedures and the Bylaws may be viewed on www.hiwire.org, including HiWire Consortium's Code of Conduct ("**Code of Conduct**"), a copy of which is attached to this Agreement. This Agreement continues in perpetuity, unless terminated by either party under the provisions of this Agreement, under any applicable HiWire Consortium policies or procedures, under any applicable provisions of the Bylaws pertaining to members.

Subject to this Agreement, Company first becomes a member of HiWire Consortium on the date on which the HiWire Consortium administrator first sends notice of enrollment to Company. Notwithstanding any other provision hereinto the contrary, HiWire Consortium may terminate Company's membership for failure to: (a) comply with this Agreement, (b) abide by any policies or procedures set by HiWire Consortium governing members, or (c) Bylaws.

## Licenses.

(a) Excepts as expressly provided herein or pursuant to a separate written agreement entered into between the parties, no license is granted by virtue of membership in the HiWire Consortium to any HiWire Consortium patents, copyrights, trademarks, service marks, trade name, or other intellectual property rights. HiWire Consortium grants Company a limited, non-exclusive, non-sublicenseable license to use HiWire Consortium's name and logo solely to indicate it is a HiWire Consortium member.

(b) Company hereby grants HiWire Consortium a limited, non-exclusive, non-sublicenseable license to use Company's name and logo and be named and listed as a member of HiWire Consortium in directories and marketing materials.

<u>HiWire Consortium Terms</u>. Company agrees not to acquire, attempt to acquire, maintain, or assert any exclusive trademark or other intellectual property or proprietary rights in the term "AEC" or the term "HiWire" or "HiWire Consortium"), in connection with any HiWire Active Electrical Cable device, specification, or technology.

Benefits. Participation in events and technical support is subject to availability.

<u>Confidentiality</u>. Company agrees not to (a) provide or otherwise disclose to HiWire Consortium or its members, directors, partners or representatives any Company confidential information and (b) use any Company confidential information in developing or creating any HiWire Consortium specifications. Draft specifications and other documents provided to HiWire Consortium membership on a "**HiWire Consortium Confidential**" basis, and shall be maintained and safeguarded by members as confidential, until formally approved by HiWire Consortium for public release.

<u>Warranty</u>. ANY GOODS OR SERVICES FURNISHED OR MADE AVAILABLE TO ANY HIWIRE CONSORTIUM MEMBER ARE PROVIDED "AS-IS WITH ALL DEFECTS" AND WITHOUT ANY WARRANTY OF ANY KIND WHATSOEVER. HIWIRE CONSORTIUM DISCLAIMS ANY AND ALL WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE, NON-INFRINGEMENT, OR MERCHANTABILITY. NEITHER HIWIRE CONSORTIUM, NOR ANY MEMBER, DIRECTOR, PARTNER, OR REPRESENTATIVE OF HIWIRE CONSORTIUM, NOR ANY SUPPLIER OR VENDOR OF SOFTWARE, HARDWARE, OR SERVICES WILL BE LIABLE TO COMPANY FOR ANY FAULT OR DEFECT IN SUCH ITEMS OR FOR ANY FAILURE TO DELIVER ALL OR ANY PORTION OF THESE ITEMS.

- 6. Comply with all applicable antitrust laws and the HiWire Consortium's antitrust guidelines;
- 7. Behave in a professional and business-like manner and not engage in any behavior that is discomforting to other individuals, that constitutes sexual discrimination or sexual harassment; and
- 8. Avoid conflicts of interest and disclose any relationship or activity that is or could become a conflict of interest. All persons subject to the Code of Conduct owe a duty of loyalty to the HiWire Consortium.

Failure to comply with the Code of Conduct may result in corrective action, including, without limitation, preclusion from attending certain events or functions or termination of membership or affiliation with the HiWire Consortium.
